

The national organistations were notified of their awards prior to 31 December 2014. Of the local allocation only £469 to the Memory Café Taunton had been awarded by 31 December 2014. Discussions were ongoing with the other local organisations to whom funding will be distributed during 2015.

Income from November and December, including gift aid thereon, will be granted in 2015 together with future fundraising totals.

Gift aid income has been put towards the costs of fundraising, covering in full the £1,650 contribution to the Mount Kilimanjaro challenge.
